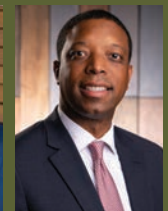

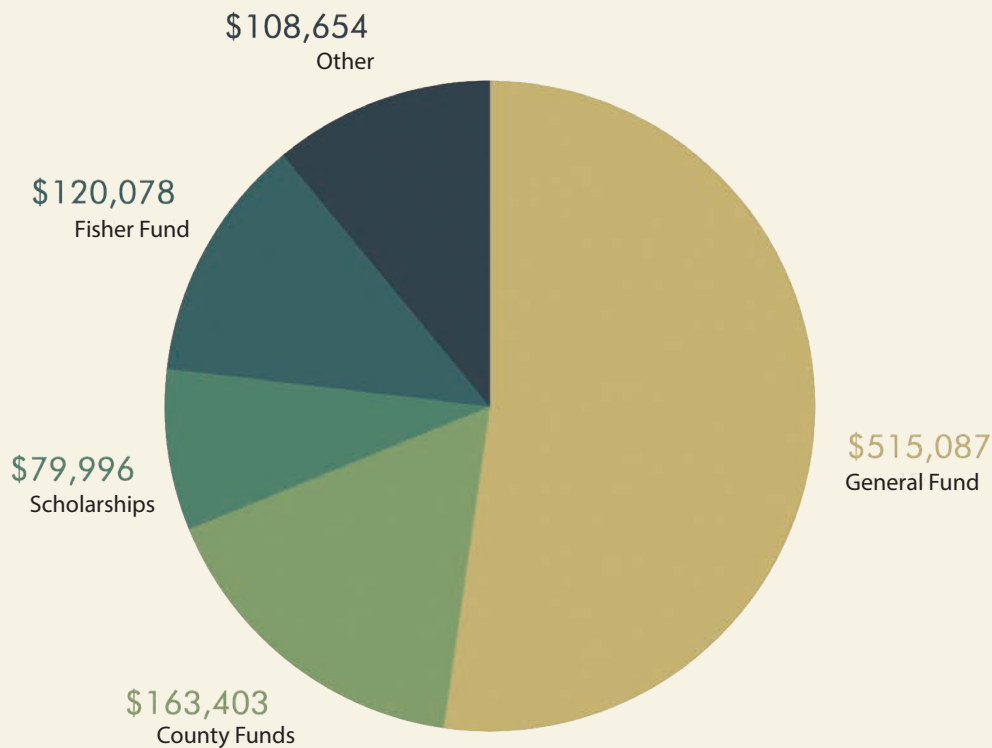

## 2022 Total Dollars Raised | \$987,218

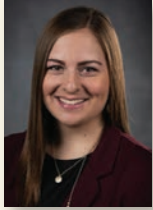

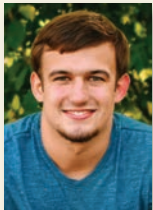

## Welding scholarship now offered in Summit County

Brad Mularcik, a long-standing member of the Summit County Farm Bureau, believes that there is too little attention paid to the skilled trades as



a career choice for young people. The Mularcik Welding Scholarship for Summit County will award its first \$1,000 scholarship to a Summit County student enrolled in a post-secondary vocational training program, college or university seeking accreditation, certification or a degree related to welding.

## Inspiring the next generation

The Junior Achievement Inspire Career Exploration Fair is the 2022 recipient of the **Youth Pathways for Careers in Agriculture Grant**. A total of \$100,000 will assist this nonprofit as it takes the traditional career fair model and turns it into a massive career exploration program focused on building a talented pipeline of agricultural professionals, utilizing in-person events and a virtual platform.

## Portage County fund expands to aid workforce development

Portage County Farm Bureau members Bruce and Carlene Patterson's deep love for agriculture was evident in a major life decision in 2022 when they sold their farm to a couple who was married



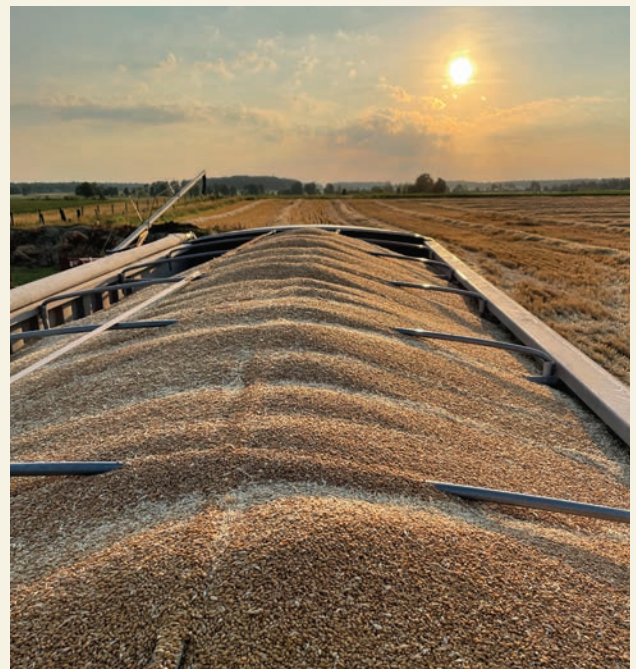

on the farm and who plan to continue farming themselves. Carrying on the tradition of the family farm has always been an important part of the Patterson family story.

The couple established the Bruce and Carlene Patterson Educational Fund five years ago. In 2022, more investment was made, which includes both sustaining the Portage County scholarship and making a strategic impact on the Ohio Farm Bureau Foundation's focus on workforce development.

## New Gift of Grain program

As farmers deliver their harvested crops to market, more of them are choosing to donate a portion of their commodities to support the Ohio Farm Bureau Foundation through the Gift of Grain program. Gifting grain directly, rather than selling first and making a gift from the proceeds, may provide a more significant tax savings. Contributing directly to the Ohio Farm Bureau Foundation allows donors to avoid the sale of the commodity as income, while the production costs may still be deductible. A donor should always consult with their tax preparer to determine the tax implication prior to making a gift.



*“Donating some of my grain and knowing that what my family has been able to grow on our farm can directly benefit the future of our industry through the Ohio Farm Bureau Foundation means a lot to me,” one farmer said. “I would encourage other farmers to consider doing the same.”*
